
OUTLANDS ADDENDUM EQUESTRIAN



Preamble

All Equestrians in the Outlands are to know the rules presented in the SCA Equestrian Marshal's Handbook and the Outlands Addendum: Equestrian handbook. The rules in the SCA Equestrian Marshal's Handbook take precedence over the Outlands Addendum Equestrian handbook. The Outlands Addendum Equestrian handbook directly adds to the rules stated in the SCA Equestrian Marshal's Handbook. The rules found here are applicable to all Equestrian activities in The Kingdom of the Outlands. All Equestrians are equally responsible for their safety, the safety of their fellow fighters, the safety of theirs and others mounts, and of the people around them. At all times, safety takes precedence and should be primary.

I) Equestrian Program

Add the following rules to this section of the SCA Equestrian Marshal's Handbook

E. Equestrian Marshals.

5a. The Outlands shall have both "Field Marshals" and "Authorizing Marshals". Field Marshals act under the direction of the Marshal in Charge upon the equestrian field to oversee the safety and the orderly action of combat. These Marshals are responsible for the enforcement of Equestrian Rules in games or combat. It is not required to possess any other equestrian authorization prior to becoming an authorized Equestrian Marshal.

Authorizing Marshals are appointed by the Kingdom Equestrian Officer and are charged with the responsibility of authorizing Equestrians for riding, games, combat, and the authorization of "Field Marshal" to oversee safety and the orderly action of Equestrian Activities. Authorizing Marshals may only authorize riders in activities that they themselves are authorized in. Authorization minimums being defined in the Society Equestrian Handbook.

II) Rider/Driver Requirements

Add the following rules to this section of the SCA Equestrian Marshal's Handbook

- C3. Ground Crew. The Equestrian Marshal in Charge (EqMIC) must approve all persons who serve as Ground Crew during an Equestrian event or practice. No authorization is required. Ground crew must wear closed toe shoes, demonstrate safe handling of equipment and weapons including the correct way to hand equipment to a mounted rider, and demonstrate an ability to maneuver safely around the horses. Ground crew must also have a valid waiver on file for the duration of the event.
 - D. Maximum term. No authorization may be for a period greater than 4 years.
- D1. Authorizations in The Outlands may be made for no longer than 4 years or until the waiver on file expires.
- D2. This properly completed waiver will be the submitted Blue Card information or waiver information submitted at the point of authorization and will be kept as record in the database of the Marshalate of the Kingdom of the Outlands.
- E. Out of Kingdom Authorizations. Valid authorization cards shall be accepted outside the issuing kingdom as proof of authorizations. Visitors with a valid authorization card from another kingdom must abide by the equestrian regulations of the kingdom they are visiting. Kingdoms may define additional requirements before renewing an authorization card for a person who has moved into that kingdom from another kingdom.
- E1. The Kingdom of the Outlands does not require re-authorization for a renewal for a person who has moved, so long as the person's card is current and the rider is in good standing with their previous kingdom. They must present a waiver on file to participate in Outlands Marshal Activities.
